

# Weekly Information Net Script

## Preamble

This is [YOUR CALL] in [YOUR MUNICIPALITY], Net Control Station for this session of the Chester County ARES/RACES Information Net. My name is [YOUR NAME].

Stations with emergency, medical, or priority traffic, call now. [pass this traffic immediately]

The purposes of this net are to provide timely information and announcements pertaining to Chester County ARES/RACES and to regularly verify radio circuits among CCAR members and between locations identified in the CCAR emergency plan. However, we encourage all licensed stations to check in and participate.

This DIRECTED net meets every Thursday at 1930 Eastern Time.

CCAR operates this net on the following repeaters with active links:

W3EOC Linked UHF System on 446.525 in West Chester, 446.175 in Northern Chester County, and 448.875 in Southern Chester County. All have minus inputs and PL of 100. The W3EOC Coatesville repeater on 441.950 is also linked. This repeater has positive offset and a PL of 100.

In the event of a failure in the Linked UHF Repeater System, net operations will shift to the N3KZ Bucktown repeater on 147.270 This repeater has positive offset and a PL of 77.0.

A copy of the weekly drill message is available on the CCAR website at [w3eoc.org](http://w3eoc.org). All stations are requested to download a copy of tonight's message and be prepared to transmit the message, if called upon by Net Control.

## **ID frequently, at least every 10 minutes**

## **Check-in**

The net will now open for check-ins.

All operators are encouraged to copy a list of stations checking in to become familiar with call signs and names, as well as practice being prepared if you should ever be asked to fill in for the Net Control Station. As you check in, please state your call sign using standard phonetics and give your name, township or borough location, and list your traffic.

[Stations on emergency power or portable stations]

[Mobile units]

[Stations with announcements] [*Note: Pass this traffic after check-ins.*]

The net will now call for check-ins according to the CCAR Training and Check-in Regions.

[Region 1, 2, 3, 4, 5] (See reference chart below)

[Any stations outside of Chester County]

[Any stations anywhere]

## **Pass Traffic**

[Call a random station and ask if they are prepared to send tonight's drill message. If so, have them pass the drill message. After trying three stations, ask for a volunteer.]

[*Call remaining stations with listed traffic*]

[THEIR CALL] this is [YOUR CALL], call your traffic, please.

## **Close the Net**

LAST CALL for stations anywhere for check-ins to the Chester County ARES/RACES Net. Please call now.

This is [YOUR CALL], Net Control. The Chester County ARES/RACES Net will now secure using roll-call checkout procedure. When called, return with your callsign, any final comments, and clear your station.

Stations interested in digital communications are invited to check into the CCAR NBEMS Net immediately following this net.
